- These competitions are not affiliated with any other competitions. No further competition scheduled or implied.
- Contestants will be judged on talent, stage presence and entertainment appeal.
- If a duo, trio or group is competing, one cash prize will be awarded to the group. Cash prizes will not be awarded per contestant in the group.
- Explicit dancing, language, music, and content are prohibited. All aspects of the performance must be family friendly and appropriate for all ages.
- Contestants may sing acapella or to professionally-recorded tracks, which the contestant must supply on a CD. Lead vocals on the track must have been removed.
- Variety of artistic and physical talents are welcome.
